### **Mission and Situational Context**

La'o Hamutuk ("Walking Together" in English) is an independent, Timor-Leste nongovernmental organization which monitors, analyzes and reports on development processes in Timor-Leste, particularly the programs and policies of the national government and international agencies operating in the country. La'o Hamutuk produces fact-based analysis to educate and empower the public on decisions being made by its representatives. We consult with and lobby decision-makers in Government, Parliament and international agencies to advocate for more equitable, sustainable and people-focused policies.

The first half of 2022 saw the two rounds of the Presidential Election conducted peacefully. Sixteen candidates contested the first round, in which 77% of registered voters participated. The valid vote turnout was the highest turnout in a first-round Presidential election since 2007, being 6% higher than in 2017 and 4% higher than in 2012. In the second round of voting on 19 April, José Ramos-Horta received 62% of the vote, securing the Presidency over incumbent Francisco Guterres (Lú-Olo). People reported that the new system of voter registration, which allows people to pre-register to vote in a different municipality to their registered address, was poorly implemented and prevented some often students studying in Dili - from voting.

President Guterres promulgated the 2022 State Budget in early January, however in April the Council of Ministers asked the Parliament to approve a 'budget rectification' to add \$1.13 billion in new expenditures. Nearly all of the proposed new spending was for a new Veterans' Fund. After then-President-elect Jose Ramos-Horta indicated that he would veto the budget, the Government rushed it through Parliament, and on 11 May Parliament approved the entire budget rectification, adding \$1.24 billion to the budget, resulting in a global consolidated total of \$3.35 billion; the outgoing President promulgated it on his second-to-last day in office. 80% of the 2022 budget is financed with withdrawals from the Petroleum Fund, but including past and future withdrawals this figure increases to 92%. At the end of 2022 the Court of Appeal found the Veterans' Fund to be unconstitutional, and its billion-dollar appropriation, which had not yet been executed, has been cancelled.

The 2023 State Budget is the first to be adopted under the new Budget Framework Law. Among other measures mandated by this law, the Government submitted a Major Planning Options Law to Parliament. The Major Planning Options Law is intended to facilitate discussion of the Government's priorities for the coming year, before the state budget proposal is finalized. While this step in the budget cycle does offer an opportunity to discuss and debate Budget priorities for the forthcoming year, the Law submitted to Parliament contained 263 'measures' without indicating how much money each will get or what priority it will be given. We hope that in future budget cycles, the Government will include more complete information about proposed budget measures to facilitate meaningful dialogue about the nation's priorities.

At the same time that the Government was making these budget decisions, the state's financial resources declined. Bayu-Undan, the only producing oil and gas field, is dwindling and will end production in 2023. The value of the Petroleum Fund's investments dropped \$2 billion during 2022, by far the largest loss in the Fund's 15-year history. At the end of 2022, the balance in the Fund was \$17.5 billion, the lowest year-end balance since 2018. Unfortunately, the 2023 State Budget documents fail to describe this ongoing risk accurately, and their scenarios about the Petroleum Fund continue to assume future returns of 4.1%/year, while failing to consider the impacts of increasing expenditure and possibly negative investment returns.


Published Government estimates suggest that the Petroleum Fund will run out in 2034. However, the fiscal cliff could come sooner than expected; the increased spending projections for years after 2023 are worrying for future budgets, and we have seen in 2022 how global stock market volatility can impact the Petroleum Fund.

The Ministry of Finance's 2023 Budget documents present one scenario to extend the life of the Petroleum Fund until 2045, requiring spending to be reduced by 3% every year through 2034. This would give more time to diversify the economy and prepare for the end of the Petroleum Fund. But

estimates in the budget books show spending, including withdrawals from the Petroleum Fund, increasing every year through 2027 (with no information after that).

The following graph shows state revenues and expenditure in the context of historical trends.





Despite the growing urgency to diversify the economy away from dependency on oil and gas production, some leaders and interest groups continue to believe the lie that oil and gas revenues will rescue Timor-Leste. After unpromising test drilling, the offshore Buffalo project was abandoned at the start of 2022. Onshore exploration for oil and gas continued – the private Australian company Timor Resources, in partnership with state-owned TimorGap, began the second stage of exploration in Covalima. TimorGap, which in late 2021 was awarded no-bid exploration contracts in an area stretching across Viqueque, Manufahi and Manatuto, socialized their Pualaka exploration project in June, and La'o Hamutuk researchers attended. So far, no onshore activities have found reserves worth developing, and La'o Hamutuk continues to advocate for diversification away from oil and gas, while monitoring these projects and their impacts on people and the environment.

The following are some highlights of our work during 2022:

- La'o Hamutuk was interviewed and cited more than 120 times in national and international media (see Appendix 2).
- ➤ We conducted initial research about petroleum activities on the South Coast, and published an article on our findings regarding public consultation mechanisms.¹
- ➤ We officially observed the two rounds of the Presidential election, and submitted reports of our findings and recommendations.²
- As local partners of the International Budget Partnership's Open Budget Survey, we launched the results of the 2021 Survey on budget transparency, participation, and accountability.<sup>3</sup>
- After two years of pandemic-curtailed public activities, we conducted public meetings in eight municipalities (see Appendix 3).
- ➤ Published two editions of our *Bulletin*<sup>4</sup> and one edition of our popular education newsletter, *Surat Popular.*<sup>5</sup>

### **Program Activities**

#### **Public events**


For the first time since 2020, we were able to carry out public activities -- including seminars, public meetings, and field research -- without the restrictions and uncertainty of the Covid-19 pandemic. We conducted public meetings, targeting a range of audiences including civil society, university students, and rural communities. We organized events in eight of Timor-Leste's 14 municipalities and responded to requests for training from several civil society groups. As local research partner of the International Budget Partnership's Open Budget Survey, we facilitated online and in-person training on budget analysis and advocacy.

### Website, blog and email lists

La'o Hamutuk's website (www.laohamutuk.org), in Tetum and English, continues to be a primary source for reliable, independent information and analysis on many issues relating to Timor-Leste, including the state budget and government finances, large scale infrastructure projects, private investment, petroleum and extractive industries, land laws, maritime boundaries and sustainable development. It now contains 21 gigabytes of information in more than 20,000 files.

We continue to collect and publish documents from many different sources, and combine them with our analysis.

We continued to update existing pages and added new ones during 2022. We also continued to post materials to our reference page.<sup>6</sup> Our website was visited by 7,100 people every day, accessing 20,700 pages.

➤ Regular updates with new information and documents to our pages on Petroleum projects<sup>9</sup>, the Bernard Collaery case<sup>10</sup>, Development Partners' meetings<sup>11</sup>, the Petroleum Fund<sup>12</sup> and many others.

We published eleven blog articles in Tetum, with English translations of ten. About 180 people accessed our blog each day in 2022. These articles are listed in Appendix 6.

### Radio programs

We broadcast eight radio programs on seven community radio stations across the country. The programs produced discussed issues including the status of human rights in Timor-Leste, the Presidential election, the Food Systems Summit, and the fiscal cliff. We interviewed guests from Government, women's NGOs and disability organizations, and academia to present useful discussion of relevant issues facing Timor-Leste. The radio programs are also available to listen to on our website.<sup>13</sup> The programs are listed in Appendix 5.

#### Bulletin

In January 2022, we printed and distributed copies of our first *Bulletin*<sup>14</sup> for the year. Its publication had been scheduled for December 2021 but was delayed to include current information on the state budget.

In December 2022, we finalized our second *Bulletin,*<sup>15</sup> with articles on topics including the fiscal cliff, food sovereignty, and public consultation in recent petroleum activities in Suai.

In November, we published our popular education publication  $Surat Popular^{16}$  on the topic of climate change. Five hundred copies were distributed during public meetings in Maliana, Maubisse, Viqueque, and Lospalos.

### Research, Analysis and Advocacy

### State Finances and Economy

During the course of 2022, we continued to monitor the state's finances, including the Petroleum Fund and the 2022 and 2023 Budgets. We helped a range of civil society groups to better understand the budget process and engage in their own budget advocacy. Our statements to the press received wide coverage. Some of the key issues that La'o Hamutuk has been educating about for many years, such as the sustainability of state finances and the perils of temporary petroleum dependency, are finally being taken more seriously by many decision-makers.

At the end of April, the Government proposed amending the enacted 2022 State Budget by adding \$1.1b in new spending, mostly for a "Veterans' Fund". Parliament approved the Government's request for an expedited process, and there was little opportunity for the public or civil society to engage in advocacy. On 5 May, La'o Hamutuk distributed an unsolicited submission<sup>17</sup> to every member of Parliament, pointing out that the measures included in the Budget Rectification were not urgent, and that Parliament should not approve the proposed rectification.

The 2023 State Budget was the first enacted under the new Budget Framework law, which was promulgated at the beginning of 2022. One of the new steps of the budget process is the Major Planning Options (MPO) Law, which should be passed by Parliament at the end of May. In response to the proposed MPO Law, we wrote a letter<sup>18</sup> to Members of Parliament, issued a press release,<sup>19</sup> held a press briefing, published a blog article<sup>20</sup>, and facilitated a televised talk show.<sup>21</sup> We noted that the Major Planning options Law was intended to be an opportunity to discuss the nation's priorities before the final proposed state budget is developed. However, the Law presented to Parliament included 263 measures; it did not identify "major options", but instead included many programs without indicating which will be prioritized or receive large allocations. Our letter to Parliament identified measures that should be prioritized in the 2023 Budget, including agriculture oriented towards local consumption, education, health, and water and sanitation. We also pointed out measures that should not be prioritized, including regional airports and the Tasi Mane project.

When the Government proposed its 2023 State Budget to Parliament in October, we made a submission<sup>22</sup> to Parliament in which we observed that despite encouraging signs that the Government is seriously discussing the nation's impending fiscal cliff, they are not yet considering effective actions to address the problem. The budget proposal outlined a scenario to extend the life of the Petroleum Fund by a decade -- until 2045 -- to give more time to diversify the economy and avoid the crisis which will come when the Petroleum Fund is used up. However, instead of gradually reducing spending as the more sustainable model requires, the budget actually projects spending, including withdrawals from the Petroleum Fund, to go up every year after 2023 through 2027.

We issued a press release<sup>23</sup> and held a press conference, which was widely covered in the media. Some of our key observations and recommendations were noted in Parliament Committee C's report, although we were disappointed that Parliamentary debaters did not focus on these key issues of sustainability. After Parliament passed the proposed Budget in mid-November, we conducted further advocacy by meeting with decision-makers in the Ministry of Finance. To deepen public discussion the impact of the proposed 2023 State Budget, we held a public seminar in December, which was attended by 57 people and featured presentations from the Ministry of Finance, the World Bank, and La'o Hamutuk. In December we broadcast a radio program on the looming fiscal cliff, and in the same month we wrote to the President,<sup>24</sup> asking him to veto the budget law to allow more time for more thorough discussion of the key issues. Although he did not veto the budget, he obtained a court ruling that the billion-dollar Veterans Fund was unconstitutional, and it was removed before the law was promulgated.

Throughout the year, we continued to bring key issues of state finances and economic diversification to the attention of a range of key groups. In April we made a presentation<sup>25</sup> to heads of UN Agencies in Timor-Leste, and presented on the resource curse in Timor-Leste to the Association of Asian Studies conference.<sup>26</sup> We also brought these issues to regional communities; we held public meetings in Suai (Covalima municipality) and Same (Manufahi municipality) in May, in Baucau in August and September, and in four other municipalities in November.

As the local partner of the International Budget Partnership, we helped to facilitate an in-depth training for local civil society groups over several days in March, May and September. We were also invited to provide training for Fokupers, ADTL, Plan and Oxfam's local partners. In April we facilitated training in budget analysis for young people participating in Plan International's network in Dili, Maubisse, and Ainaro.

#### Oil and Gas

The offshore Bayu-Undan field has provided 94% of Timor-Leste's oil and gas revenue since independence, but the field is nearly exhausted, and production will cease in 2023.

As some in Timor-Leste seek ongoing petroleum income from other sources, we continued to monitor, explain and analyze events related to non-renewable resources in Timor-Leste. In 2022, La'o Hamutuk staff published an article on the Resource Curse in Timor-Leste in a Mexican academic journal.<sup>27</sup>

We conducted two field visits to observe the impacts of petroleum exploration in Covalima and Manufahi, the initial phase of research into community understanding of the project and how their initial expectations compare to their experiences. We published an article about public consultation and socialization for the Feto K'maus exploratory drilling activities in our December *Bulletin*. We found that the local community did not feel engaged or empowered by the consultation process, and that they had not received clear and detailed project information. We hope these findings can help future projects conduct better socialization and consultation with affected communities.

In June, we travelled to Laclubar to observe TimorGAP's 'socialization' event for new exploration activities there. In addition to the Minister of Petroleum and Mining and the National Petroleum and Minerals Authority (ANPM), civil and military officers from all three municipalities participated, including PNTL and F-FDTL commanders. We published a blog<sup>28</sup> summarizing our observations and will continue to monitor whether the closing remarks of the TimorGap President, promising deeper consultation in the future, result in genuine community engagement.

In August we looked into the status of the TL Cement project by talking to local communities and authorities in Baucau. TL Cement was allocated \$50 million in the 2018 State Budget but the money has not been transferred, and the current status of the project is unclear, especially after a September 2022 Audit Court Report found significant irregularities. We will continue to gather and confirm information.

Since 2021, La'o Hamutuk has been monitoring and analyzing the progress of the proposal to capture and store carbon dioxide (CCS) in the empty Bayu-Undan field. In February we made a submission<sup>29</sup> to the Northern Territory's Environmental Protection Authority, in relation to the Barossa pipeline duplication project. This project -- in Australian maritime territory and not having an immediate impact on Timor-Leste -- is part of the overall Barossa gas project that Bayu-Undan CCS would facilitate. Our submission argued that evaluating individual components of a major project in a piecemeal fashion risks ignoring the broader impacts of the project, including the climate damage resulting from carbon-intensive Barossa gas. We continue to be concerned that the proposed CCS project is poorly understood in Timor-Leste. We published a blog article<sup>30</sup> and led several seminars<sup>31</sup> for students and civil society to increase awareness.

### **Governance and Human Rights**

In the lead-up to the Presidential elections, La'o Hamutuk worked to promote meaningful discussion of the nation's future. We created a webpage to share key election documents<sup>32</sup> and distributed a survey to Presidential candidates. La'o Hamutuk staff conducted monitoring on both polling days and

published two reports with our observations and recommendations.<sup>33</sup> We broadcast a radio program<sup>34</sup> and published a blog article<sup>35</sup> discussing voting access and key issues with the director of the national disability organization Rae's Hadomi Timor Oan (RHTO), the director of Fokupers and a member of the Youth Parliament Alumni Organization. The December edition of our *Bulletin* includes an article reflecting on the Presidential election, to promote better implementation of the 2023 Parliamentary elections.

In 2022, as the culmination of our work as local research partners of the International Budget Partnerships' 2021 Open Budget Survey, we began releasing results within Timor-Leste. In this survey, Timor-Leste's scores are a little better than in the previous survey; the nation's transparency score increased to 52/100 and oversight increased to 56/100. However, the survey shows that the government has not yet implemented effective means of public participation, which scored 7/100. At the end of June we issued a press release<sup>36</sup> and a short video<sup>37</sup> explaining the results. We shared the results of the survey with members of civil society at a public meeting in July and with students at two Dili university campuses in November. This survey helps advocacy around transparency, public participation, and oversight in the budget process.

In August we called attention to large gaps in online Government information channels,<sup>38</sup> such as ministerial websites and online portals. This review shows a widespread failure to make timely and relevant information accessible, and some Government websites are used more to publicize past events than to share useful information. Our December *Bulletin* assessed the state of transparency in 2022.<sup>39</sup>

We continued to advocate for good governance through direct advocacy with Government institutions. Following the launch of the National Agency for Planning, Monitoring and Evaluation (ANAPMA), we initiated a meeting with agency officials in April to better understand how they are instituting state budget planning, monitoring and evaluation processes, and to advocate for transparency and inclusion. In June we were invited to present at a workshop organized by the Anti-Corruption Commission, on evaluating the risk of procurement corruption in the health sector.

We continued to participate in local NGO networks, which often strengthen advocacy by sharing information and resources and making joint submissions. During the first half of this year, we participated in regular meetings of PN-BESI.TL (Water and Sanitation Network). La'o Hamutuk staff helped them analyze state spending on water and sanitation. We also participated in meetings of the RDDU (Human Rights Defenders Network) and UADU (UN Human Rights Advisory Unit) to share updates about human rights, including violence perpetrated by government officials including F-FDTL (military), PNTL (police) and civil security and municipality sanitation task force teams.

Continuing our participation in two 2021 submissions to the third UN Periodic Review of Human Rights in Timor-Leste, we posted relevant materials to our website.<sup>40</sup> La'o Hamutuk worked with Civicus to present testimony by video to the UPR adoption in Geneva in July 2022.<sup>41</sup> We discussed the implications of this Periodic Review with the National Director of Citizenship and Human Rights and the Director of the Alola Foundation in a radio program.

### Food Sovereignty, Agriculture and Environment

During 2022, we monitored agricultural policies and indicators and environmental issues, and shared our analysis at a range of events organized by La'o Hamutuk and others.

We continued to monitor the Cesta Bázika program, a "basics basket" program introduced by the Government in 2020 to respond to the economic impacts of the pandemic and lockdowns. In the first half of 2022, the program entered its 'second phase;' it has been extended into 2023. In April and June we met with officials from the Secretary of State for Cooperatives, the Ministry of Tourism, Commerce, and Industry to better understand how the program can support local agricultural production, and to lobby for greater engagement of local producers. We discussed these issues in a radio program with the Secretary of State for Cooperatives, the National Director of Food Security, and a member of the Youth Parliament Alumni Association.

We also monitored key statistics related to agricultural production, and wrote to the Ministry of Agriculture in August to make several recommendations related to published and unpublished data about the imports of agricultural products; the Ministry agreed and included additional data in their next quarterly report (October-December 2022).<sup>42</sup> We wrote an article for our *Bulletin* on food sovereignty, which included an evaluation of recent production levels.<sup>43</sup> Worryingly, agricultural output for some key staples has fallen over the past decade. We also note the lack of data on production of fruits and vegetables, and recommended that the relevant authorities better monitor progress in this area so that we can better address food security and nutrition issues in the population.

We used other La'o Hamutuk activities to further our understanding of issues of land, agriculture, and environment and the talk to a wide range of communities about key issues. Our research activities in Suai, detailed above in the section on Oil and Gas, allowed us to investigate how land rights are upheld in relation to onshore oil and gas exploration. We also used this opportunity to conduct public workshops in Suai and Same, which discussed climate change (and its impacts on agricultural production) as well as land rights. We discussed similar issues in public meetings in Viqueque, Lospalos, Maliana and Maubisse.

Many people in Timor-Leste, including farmers, have observed the impact of climate change on weather patterns and agricultural production. We have observed that there is still a poor understanding of climate change, and its causes and solution. We continued to work to increase public awareness of climate change and climate justice. We held a seminar at UNTL to mark World Environment Day in June, gave presentations on climate change and the proposed Carbon Capture and Storage project, and invited Prof Antero da Silva to present on agro-ecology. We produced a video<sup>44</sup> and a *Surat Popular*<sup>45</sup> on climate change, and organized public meetings in four municipalities in November.

We monitored discussions and debates at the COP27 conference in Egypt, and wrote an article explaining the origin and implications of the decision on a Loss and Damage Fund.<sup>46</sup>

We also continued to update our webpage on environmental licensing documents, an effort to fill the gap caused by the government's failure to maintain a publicly available registry.<sup>47</sup>

### Plans for 2023

We will continue to engage in research, analysis, and advocacy in relation to state finances and the economy, governance and human rights, land rights and agriculture, and petroleum and natural resources. Guided by our strategic plan, we will continue to implement a range of advocacy and public education strategies to communicate effectively with a range of target groups.

Our specific goals for 2023 are:

- ➤ Write at least eight submissions or open letters to decision-makers on key themes, including proposed legislation and policies such as the state budget and public finances, offshore and onshore petroleum activity, contracting and other issues.
- Follow the 2024 State budget process, including written and oral testimony to Parliament, briefings for MPs, the media and civil society in Dili and Municipalities.
- Continue to monitor the Petroleum Fund's revenues, investments and withdrawals, and the implications for the sustainability of state finances.
- Conduct two training sessions for civil society
- Broadcast six Radio Igualdade programs
- > Produce one edition each of our Bulletin and Surat Popular
- Recruit one local researcher and one international researcher.
- ➤ Promote substantive discussion of key issues in the 2023 Parliamentary Election, help the public access key information, and monitor the election process.
- > Produce a short video and produce a TV talk show on relevant issues
- > Publish a brochure with questions to ask political parties during the election campaign
- > Conduct strategic meetings with government officials and other key actors about the current economic and social situation.

### **Appendix 1. Financial Report**

All amounts are specified in U.S. dollars. La'o Hamutuk's fiscal year is the calendar year.

The organization has a flat wage structure; local and international staff received take-home salaries of \$846.36 per month from January to December 2022, plus the legally-mandated 13<sup>th</sup> month salary at the end of the year. According to Timor-Leste law, in addition to Wage Tax, 10% of pre-tax salaries must be paid into the government's social security program; the organization pays 6% and the employee pays 4%. International staff receive one return airfare from their home country, as well as a readjustment allowance of \$200 for each month worked up to the end of their first year, payable after they finish working with La'o Hamutuk. According to Timor-Leste's Labor Code, Timorese staff who have worked for more than one year are entitled to severance pay when they leave the organization. Staff members who must move to Dili to work at La'o Hamutuk receive up to \$200/month toward house rental costs.

Our work in 2022 was supported by grants from Misereor/KZE, the Norwegian Embassy in Jakarta (administered by Yayasan Humanis dan Inovasi Social, HIVOS), Comité Catholique contre la Faim et pour le Développement (CCFD) and The Asia Foundation (TAF). La'o Hamutuk also earned money from the International Budget Partnership, PFMO, Plan International, AVI and OXFAM for providing research and trainings.

In order to ensure that everyone understands that La'o Hamutuk is independent, we maintain our long-standing policy of not accepting contributions from institutions with a significant interest in Timor-Leste: the UN and its agencies, the World Bank, ADB, IMF, major multilateral and bilateral donors to Timor-Leste, the Timor-Leste government, and transnational corporations operating here.




