TETUN:

Loron di'ak ba imi hotu! Ha'u-nia naran Peter. Ha'u servisu hanesan Embaixadór Austrália nian ba Timor-Leste.

Agora daudaun, ha'u simu pergunta barak kona-ba ratifikasi saun Akordu Fronteira Marítima. Entaun, ha'u hakarak fahe informasaun kona-ba saida maka akontese daudaun.

Iha loron 6 fulan Marsu tinan ida ne'e, ita hotu selebra loron asinatura istóriku Akordu Fronteira Marítima entre Austrália no Timor-Leste. Ita-nia NASAUN RUA hatudu exemplu ida ba mundu hodi rezolve ita-nia fronteira marítima liu hosi Komisaun Konsiliausun dahuluk liu ne'ebé estabelese iha UNCLOS nia okos. Agora hamutuk ita haree ba oin hodi selebra bainhira Akordu ne'e vigór ona. Sei iha progresu RUA ne'ebé presiza completa antes ida ne'e bele akontese.

Primeiru, NASAUN RUA presiza completa sira-nia progresu aprova akordu doméstiku. Segundu, presiza iha akordu ba aranjamentu tranzisionál ho kompañia sira ne'ebé sira-nia operasaun petróleo sei muda ba Timor nia teritóriu ekskluzivu bainhira Akordu ne'e vigór.

Ida primeiru, ami halo ona progresu ne'ebé signifikante tebes. Eis Ministra Bishop apresenta ona Akordu ne'e ba Parlamento Austrália nian iha loron 26 fulan Marsu, semana hira deit depois de Akordu ne'e asina. Komisaun Parlamentár Austrália nian kona-ba Tratadu sira completa ona konsultasaun pública no rekomenda ona katak Austrália tenke halo ona asaun hodi lori Akordu ne'e ba vigór lalais. Ami agora halo hela lejislasaun atu implementa Akordu ne'e iha Australia nia lei.

Ida segundu, ofisiál sira hosi Australia no Timor-Leste agora servisu hamutuk ho kompañia sira atu finaliza aranjamentu sira ne'ebé sei aplika bainhira operasaun petróleo muda tama ba Timor-Leste nia jurisdisaun ekskluziva iha Akordu foun nia okos. Servisu ida ne'e kompleksu no tékniku maibé halo ona progresu ne'ebé forte.

Kuandu progresu RUA ne'e completa ona, Austrália no Timor-Leste sei notifika malu katak ita prontu atu halo Akordu ne'e vigór.

Loron ida ne'ebá sei sai loron ne'ebé furak. Ho tempu hanesan, ami sei informa ita boot sira kuandu iha mudansa ruma.

ENGLISH:

Good day everyone! My name is Peter, and I am the Australian Ambassador to Timor-Leste. Recently, I have been asked many questions about the ratification of the Maritime Boundary Treaty. So, I would like to share with you some information on what is currently happening.

On 6 March this year, we celebrated the signing of the historic Maritime Boundary Treaty between Australia and Timor-Leste. Our two countries set an example to the world by settling our maritime boundary through the first ever Conciliation Commission established under UNCLOS. We now look forward to celebrating when the Treaty enters into force. There are two processes that need to be completed before this can happen.

First, both countries need to complete their domestic treaty approval processes. Second, transitional arrangements need to be agreed with the companies whose petroleum operations will move into exclusive Timorese territory when the Treaty takes effect.

On the first, we have made significant progress. Former Foreign Minister Bishop tabled the Treaty in the Australian Parliament on 26 March, just a few weeks after it was signed. Australia's Parliamentary Committee on Treaties has completed public consultations and recommended that Australia take action to bring the Treaty into force as soon as possible. We are now drafting legislation to implement the Treaty under Australian law.

On the second, Australian and Timorese officials are working closely with the companies to finalise arrangements that will apply when petroleum operations move into exclusive Timorese jurisdiction under the new Treaty. This work is complex and technical but solid progress is being made.

I would like to thank the ANPM and other agencies for their hard work and great leadership to finalise the arrangements.

Once these two processes are complete, Australia and Timor-Leste will notify each other that we are ready for the treaty to enter into force.

It's going to be a great day. In the meantime, we'll keep you posted. Thank you and have a nice day!
