Agenda for Discussion:

1) Reporting Template

Secretariat TL-EITI has table the agenda for discussion which is report template as reflect to MSG concern in previously year that the MSG proposed to elaborate reporting template for TL-EITI 2012 before engage Aggregator Body (**AB**).

However in today meeting MSG noted that each pillar might not have sufficient time in elaborating reporting template TL-EITI, because of each pillars have other responsibilities and commitments, therefore MSG proposed to amend the discussion for the day to cover discussion on engagement with Aggregating Body. This could be done in two ways, either continue with the existing contract with Moore Stephens (**MS**) or open new tender in order to assist MSG in drafting the new report templates and compiling Data for the report.

At the moment, MSG cannot make decision because the meeting was not attended by all members with voting power.

In addition to that MSG have noted the need to include the contextual information in the upcoming report as reference see (requirement 3) new standard 2013. But MSG need to discuss on the agreed definition for contextual information.

If continue engage with MS, MSG need to review the ToR and amend the Scope of work for AB as following:

1. Draft a new reporting template using reference of 2009, 2010 and 2011 include template report for State Own Company (SOE)
2. Compile contextual information of the extractive industries

Action: Secretariat will call for next meeting and ensure that all MSG members with voting power are present.
