Minutes of Pre-Bid Meeting held on 25 February 2013

Upgrading of Existing Suai Airport IFB No: ICB/035/TGAP-2013

- 1. The pre-bid meeting for the Upgrading of Existing Suai Airport, IFB No: ICB/035/TGAP-2013 was held at 10:30 hours local time on February 25, 2013 at the CNE Office located at Rua Jacinto, Caicoli, Dili. Mr. Greesh Sharma, Senior Procurement Specialist, CKP, welcomed the attendees of the meeting and gave a brief introduction on the purpose and importance of the meeting. As the meeting was mandatory, each of the prospective bidder's representatives was advised to sign in the attendance sheets and give their e-mail address including their designation in the company they represent to the Secretariat.
- Mr. Sharma introduced the members of the panel coming from Timor GAP, NPC, CKP and the Design Consultant
- The Design Consultant made a brief presentation of the design features of the proposed project including the
 existing conditions prevailing in the area. The presentation included identification of existing quarries and
 location of potential sources of construction materials.
- 4. After the presentation, the bidders were requested to ask questions. The questions pertaining to the technical and design aspect of the project was answered by the Consultant and Timor GAP while the bidding requirements and commercial part was answered by NPC and CKP. The questions asked during the pre-bid meeting along with the questions received before the meeting and answers provided are enclosed.
- At the end of the meeting Mr. Aniceto do Rosario thanked all the attendees for their active participation in the question and answers potion of the meeting.
- The meeting was concluded at 12.45 hours the same day on 25 February 2013.

Do we need to form a JV with national contractor in order to bid or not? | It is not mandatory for foreign Bidders to have a joint venture with local Bidders. However, the Bidders are encouraged to involve local Bidders in some form like sub-contractors, etc. As mentioned in the ITB 4.1 of the Bid Documents, a Bidder may be a natural person or a private entity or a combination of them with a formal intent to enter into an agreement or under an existing agreement in the form of a Joint Venture (JV). The Invitation to Bids published is not part of the Bid Documents as mentioned in the ITB 6.2 of the Bid Documents. |
