- Rui Maria Alves Soares, ba kargu **Prezidente Konsellu Administrasaun nian maka Prezidente Komisaun Ezekutiva TIMOR GAP, E.P. – Timor Gás & Petróleu, E.P (“TIMOR GAP”)**, ba mandatu ida ho durasaun tinan haat.

Hanesan empreza públika referénsia nian iha setór enerjétiku, TIMOR GAP hetan mandatu hodi jere investimentu sira Estadu nian iha setór petrolíferu no setór relevante sira, tuir polítika ne'ebé define ona husi Governu.

- José Manuel Gonçalves, ba kargu **Prezidente Konsellu Administrasaun no, ho inerénsia, Prezidente Komisaun Ezekutiva Murak Rai Timor, E.P.**, ba mandatu foun ida ho durasaun tinan haat.

- Job Brites dos Santos, ba kargu **Prezidente Konsellu Direтиву Institutu Jeosiénsias Timor-Leste, I. P. (IGTL – sigla iha lian portugés)**, ba mandatu tinan haat.

IGTL nu'udar institutu públiku ida ho ninia misaun atu poténsia kriasaun no jestaun arkivu, produsaun, jestaun, armazenamentu no difuzaun informasaun jeolójika, inklui kona-ba rekursu petrolíferu, gás naturál no mineirais, sai hanesan baze serbisu prospesaun, peskiza no esplorasau rekursus minerais nasional.

Nomeasaun ba Rui Maria Alves Soares, José Manuel Gonçalves, Gualdino do Carmo da Silva, Rafael Danilson Magno de Araújo no Job Brites dos Santos, tau iha konsiderasaun ne'ebé rekoñese ona ba sira-nia idoneidade, integridade, formasaun akadémika no profesionál, esperiénsia ba kargu superiór sira, kapasidade téknika iha jestaun ba setór espesífiku petróleu, gás no rekursus minerais, koñesimentu polítika no estratéjika ne'ebé relaciona ho setór sira-ne'e, aleinde kompeténsia lideransa, kolaborasaun, pedagogia no motivaun ekipa sira. Karakterístika sira ne'ebé hatudu esensial ba dezempeñu sira-nia kargu iha entidade ida-ne'e (TIMOR GAP, E.P., Murak Rai Timor, E.P., ANP, ANM no IGTL), iha kuadru servisu interese públiku ne'ebé organizaun sira ne'e dezempeña ba servisu Estadu.

Meeting of the Council of Ministers on September 13, 2023

Five draft government resolutions were approved, presented by the Minister of Petroleum and Mineral Resources, Francisco da Costa Monteiro, for the appointments of:

- * Rui Maria Alves Soares, to the position of Chairman of the Board of Directors and, inherently, Chairman of the Executive Committee of TIMOR GAP, E.P. - Timor Gás & Petróleo, E.P ("TIMOR GAP"), for a four-year term.

As a public company of reference in the energy sector, TIMOR GAP is mandated to manage the State's investments in the petroleum sector and related sectors, in accordance with the policy defined by the Government.

- * José Manuel Gonçalves, to the position of Chairman of the Board of Directors and, inherently, Chairman of the Executive Committee of Murak Rai Timor, E.P., for a four-year term.

Murak Rai Timor, E.P., as a Public Company of reference in the mining sector in East Timor, is mandated to act in the interests of the State in that sector, namely by carrying out Mining Activities, in accordance with the policy defined by the Government.

- * Gualdino do Carmo da Silva, to the position of Chairman of the Board of Directors of the Autoridade Nacional do Petróleo, I.P. (ANP), for a term of 4 (four) years.

The ANP is a public institute with powers to act as a regulatory body for the oil, natural gas and derivatives sectors and industries, and related sectors.

- * Rafael Danilson Magno de Araújo, to the post of Chairman of the Board of Directors of the Autoridade Nacional dos Minerais, I.P. (ANM), for a four-year term of office.

The ANM is a public institute whose remit is to act as a regulatory institution for the mineral resources sector in scrupulous compliance with the provisions of the Mining Code and any existing or future legislation or regulations governing the mineral resources sector.

- * Job Brites dos Santos, to the position of Chairman of the Board of Directors of the Institute of Geosciences of Timor-Leste, I.P. (IGTL), for a four-year term.

The IGTL is a public institute with the mission of fostering the creation and management of the archive, production, management, storage and dissemination of geological information, including that relating to petroleum, natural gas and mineral resources, serving as a basis for prospecting, research and exploration of national mineral resources.

The appointments of Rui Maria Alves Soares, José Manuel Gonçalves, Gualdino do Carmo da Silva, Rafael Danilson Magno de Araújo and Job Brites dos Santos take into account their recognized suitability, integrity, academic and professional training, experience in senior positions, technical capacity in the management of the specific sectors of oil, gas and mineral resources, knowledge of policies and strategies related to these sectors, as well as leadership, collaboration, teaching and team motivation skills. These characteristics are essential for the performance of their positions in the respective entities (TIMOR GAP, E.P., Murak Rai Timor, E.P., ANP, ANM and IGTL), within the framework of the public interest service that these organizations perform for the State.

Ne'e rekoñese katak iha interese públiku ba akizisaun rápida ekipamentu sira ne'ebé temi ona hodi implementa Estratéjia ne'e.
