**PETITION FOR HEARING**

The petitioner, US Bank, Custodian for BV Trust 2015-1 (the “Petitioner”), being a third party who claims a legal right, title and interest in the real property affected by the within matter, hereby petitions the United States District Court for the District of New Jersey for a hearing to adjudicate the validity of its legal interest in said property.

The basis for the Petitioner’s claims is as follows:

1. The Petitioner is the holder of a tax sale certificate bearing number 14-00001, which was acquired by it at a tax sale for unpaid municipal taxes held on June 3, 2015 by the Borough of North Haledon. The Certificate is secured by property located 36 Rosewood Court, North Haledon, New Jersey in which the Defendant has an interest (the “Property”).
2. As of June 22, 2017, there is due on the Certificate the sum of \$108,743.68 which includes a premium paid by the Petitioner for the Certificate of \$51,100.00. Interest continues to accrue at the rate of \$16.22 per day.

3. The Petitioner seeks to have the Certificate paid from the proceeds of sale at such time as the United States of America sells the Property.



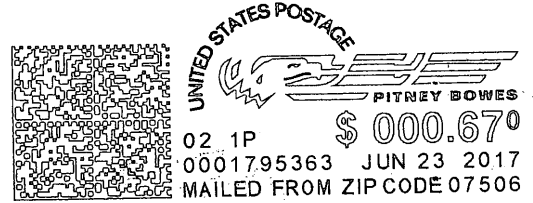
