






## Kitan fó tokon \$900 ba TL, 5% husi montante ne'ebé Bayu-Undan kontribui.

## Projetu infrastrutura petrolíferu Tasi Mane

Inklui baze fornesimentu Suai, refinaria Betano, planta LNG Beaçu, auto-estrada 156 km, kadoras tasi laran no rai-maran, aeroportu 2 no portu 2.

Durante 2011-2016, TL gasta tokon \$286 ba ida ne'e.

Total kustu ba projetu bele to'o biliaun \$15 (barak liután se Timor-Leste selu rasik ba refinaria, kadoras ka planta LNG).

Iha orsamentu 2017 aloka tokon \$65 iha 2017 no biliaun \$1.62 iha entre 2018-2021, maibé husik hela item sira ne'ebé boot liu hotu.

Timor-Leste asina kontratu boot liu hotu iha istória TL nian iha 2015: tokon \$719 atu harii Baze Fornesimentu Suai. Kontratu ne'e anuladu ona, maibé governu halo rekursu ba tribunal.



## Disputa Sunrise no fronteira maritima.



Tratadu CMATS 2006 bandu diskusaun fronteira maritima ba tinan 50. Nia fahe reseita produsaun husi Sunrise nian ba 50-50.

Australia tau uluk ninia kaan-ten ba mina duke ninia respeitu ba viziñu sira nia soberania ka direitu internasional.

Bazeia ba UNCLOS, TL mak na'in ba area hotu iha norte husi liña median nian.

In Janeiru 2017, Australia simu Timor-Leste nia pedidu atu kansela Tratadu CMATS tomak. Negosiasaun sira ba fronteira nian oras ne'e daudaun la'o hela.

### TIMOR-LESTE PETROLEUM VALUE POTENTIAL (to be explored & developed in the next 50 years)

- Timor-Leste's TOTAL PETROLEUM INITIAL -IN-PLACE (PIIP) is in the range of **12-17 Billion Barrel Oil Equivalent (BOE)**
- TIMOR GAP estimates the recoverable resources will be around **6.3 Billion BOE** (as a comparison Bayu Undan reserve is ~ 1 Billion BOE)
- The monetary value of these resources at average US\$ 59 /barrel in the next 50 years is **US\$ 372 Billion**
- Assuming the cost per barrel = US\$ 35/barrel, then a total of at **US\$ 220 Billion** will go into the expenditures in exploration, engineering, simple to complex services, fabrications (small, medium to larger scale), installations/constructions, operations and maintenance.
- Therefore, the country want to develop its infrastructures, capabilities in the services, engineering and fabrications in the next decades to capture some of these expenditures in its economy.*

## ANPM: TIMOR-LESTE RESERVES VOLUME AND PROSPECTIVE RESOURCES<sup>1-4</sup>



- ANP data set up to ~2.6 BBOE
- Significant opportunity for future Timorese participation in petroleum
- Expected reserve range of 5 - 160 mmboe / field
- Largely Greater Sunrise and Bayu Undan
- Represents easiest molecules to produce & near- to mid-term focus

High Reserves / Resource life as a result of undeveloped Sunrise field resources & declining production
