



- **1972 - 'Australia-Indonesia Seabed Boundary'**
- **1974 – Woodside deskobre Sunrise**
- **1975 – Indonesia invade Timor-Leste**
- **1989 – 'Timor Gap Treaty'**
- **2000 – UN asina 'Timor Sea Arrangement' ho Australia**

Kronolojia ba fronteira maritima

- **Mar 2002 – Australia retira-an husi artigu 'konsiliaun obrigatóriu' iha UNCLOS**
- **2002 – TL asina 'Timor Sea Treaty' ho Australia**
- **2003 – TL asina 'Sunrise IUA' ho Australia**
- **2006 – TL asina 'CMATS' ho Australia**
- **2017 – TL-Australia termina CMATS**


Esplikasaun kada tratadu 1/1

- **'Australia-Indonesian Seabed Boundary' (1972)** – kria fronteira entre Indo ho Australia, falta de'it 'Timor Gap'
- **Timor Gap Treaty (1989)** – kria ZOCA, fahe rekursu iha ZOCA 50-50 entre Indo-Aust
- **Timor Sea Arrangement (2000)** – kria JPDA ne'ebé troka ZOCA, fahe rekursu iha JPDA 50-50 entre TL-Australia
- **Timor Sea Treaty (2002)** – fahe rekursu iha JPDA 90-10 TL-Australia

Esplikasaun kada tratadu 2/2

- Sunrise International Unitization Agreement (IUA) (2003) – fahe Sunrise 80% tomak ba Australia, 20% restu mak fahe 90%-10% entre TL ho Australia
- Certain Maritime Arrangements in the Timor Sea (CMATS) (2006) – fahe reseitas ‘upstream’ husi Sunrise 50-50 entre Aus-TL
- Tratadu Fronteira Maritima 2017 - ???

Prosesu atu termina CMATS 1/2

- Iha 2013, TL lori kazu ba Tribunal Internasional Justisa iha Olanda
- Kazu ne'e bazeia ba alegasaun katak ASIS (ajénsia intelijénsia Australia) halo espiónagen durante prosesu negosiasaun
- Prosesu la'o entre 2014-2016
- Gov TL kria Gabinete Fronteira Marítima iha 2015 hodi kontinua kazu legal no negosiasaun
- Gov TL lori asuntu FM ba ONU iha 2015

Prosesu atu termina CMATS 2/2

- Labour Party Australia deklara iha 2016 katak sira sei komesa negosiasaun ho TL karik sira manán iha eleisaun
- Liberal Party mak manán – maibé, diskusaun kona-ba FM iha media no público iha Australia aumenta durante 2016
- Sept 2016 – Komisaun Konsiliaun rejeita Australia nia pozisaun, no deklara sira iha duni jurizdisaun hodi rona kazu
- Jan 2017 – Nasaun rua konkorda atu termina CMATS iha fulan Abril
